KIDS IN THE GARDEN

Except as expressly identified by me in the Child's Kids In the Garden Registration Form, I am not aware of any health or medical conditions the Child may have that would suggest to me that the Child should not be a participant in the Activities operated or provided by the Warman Collective Garden (WCG). I have not been advised that the Child should not participate in the Activities by a qualified health care provider, or otherwise.

I understand that there is risk of serious injury, harm or death to the Child arising from the Child's participation in the Activities, which may include injuries sustained from falling (of the Child, or others, or the falling of objects), collision (with equipment, projections on the floor or otherwise, or with other participants, etc), kitchen hazards (including but not limited to equipment and appliances) or the failure to operate or maintain properly, or the misuse of, the facilities and/or equipment utilized for the Activities, in which I have requested the Child be permitted to participate. I understand that this form shall bind me and apply to all of the Activities and other activities and programs operated by WCG and in which the Child may participate, including travel and transportation of the child.

In consideration of the Child being permitted to participate in, or be a member of, any of the present and/or future child care programs operated or provided by Warman Collective Garden and, in particular, the Activities and all of the related activities, events and occurrences (including transportation of the Child), and on behalf of both the child and myself (including my trustees, administrators, heirs, next of kin, successors and assigns), I hereby and irrevocably waive release and

discharge WCG, including all of its employees, directors, officers, agents, trustees, representatives, contractors, sub-contractors, drivers, volunteers, other participants and or/members, predecessors, successors and assigns ("the Releases"), for and from any and all injury, harm, and/or damages of any kind, howsoever caused or arising from the Releasee's own negligence, as well as any and all liability arising from, or related to, directly or indirectly, the Child's death, disability, personal injury, property damage or property theft, or any other claims for damages the Child or I may now or in the future, including those related directly or indirectly to the Child's participation in the Activities.

I hereby authorize the Warman Collective Garden to use the Child's photo and/or information to his/her experiences with the Kids in the Garden. I understand this information may be used in publications, including electronic publications, audiovisual presentations, promotional literature, advertising, community presentation, letters to area legislators, media and/or other similar ways,

I understand that this form will be used against me in any proceeding in which I make any claim of any kind against the Releasee's, on my own or on behalf of, or as a representative of, the Child.
